

Agreement for Investigative & Security Services One-Time Contract

The agreement, made this day of _____, by and between _____ herein after called **CLIENT** and **QUALLS SECURITY & INVESTIGATIONS, Inc.**, specializing in security and investigative work, herein after called **AGENCY**. Whereas, **CLIENT** desires to employ a security and detective agency & investigator(s) to furnish certain services to **CLIENT** whereas the **AGENCY** submits a proposal for the aforesaid services as follows:

SECURITY AND SURVEILLANCE

1. The **AGENCY** shall be hired at a rate of \$_____ per hour, per agent.
2. The **AGENCY** shall be hired for a minimum charge of six (6) consecutive hours per day.
3. The **AGENCY** will be available and will provide services for up to twenty-four (24) hours per day as agreed upon.
4. In the event the **AGENCY** is retained, and/or cancelled, **CLIENT** shall be billed at a minimum rate of two (2) hours for setup and review.
5. **FLAT RATE** option: **CLIENT** agrees to pay \$_____ for _____ days, at _____ hours per day. Additional hours will be charged as mentioned in paragraph # 1.
6. Refund policy shall be set forth as follows:
(A) Written notification of termination of services must be received by the **AGENCY** by certified mail, or hand delivery.
(B) Services in progress at time of receipt of termination shall be accordingly.
7. **COLLECTIONS POLICY** shall be set forth as follows: (A) **CLIENT** placed for collection shall be liable for all expenses and legal fees. (B) **CLIENT** confidentiality ceases at non-payment. (C) The **CLIENT** is responsible for 1.5% interest charge on unpaid services, compounded monthly. (D) The **CLIENT** is liable for any incident(s) that occur during **AGENCY** investigation, which lead to additional expenses, or the need for **AGENCY** to be represented by legal counsel. (E) **CLIENT** has authorized **QUALLS SECURITY & INVESTIGATIONS, Inc.** to charge their credit card for services agree to not contest transactions for payment of services without first contacting our office.

Now therefore, this agreement witnesseth that or and in consideration of the mutual covenants and promises between the parties hereto, it is hereby agreed that the **AGENCY** shall furnish such security and/or detective services and that the **CLIENT** shall make payment for the same in accordance with the terms and conditions set forth above. This agreement shall in interpreted in accordance with the laws in the State of Maryland. In the event, of a dispute between parties the same shall be resolved in accordance of the rules and regulations of the Cecil County Court system, Elkton, MD.
